***Ohio University Zanesville Open Rodeo-Themed Art Contest  
SUBMISSION AGREEMENT***

I am voluntarily submitting an original illustration (or illustration/drawing) to Dr. Jimmy D. Taylor, Assistant Professor of Sociology at the Ohio University Zanesville ("Sponsor") so that the sponsor and official contest judges will consider the Submission for entry in the Ohio University Zanesville Open Rodeo-Themed Art Contest. I warrant and represent that: any and all statements made in the Submission are accurate and true; It is my own original creation; the use of the Submission for or in connection with the Contest will not violate or infringe upon any third party's rights and I have the legal right and authority to submit the Submission and all portions thereof for purposes of the Contest.

I represent that I am eligible to participate in the Contest based on the Contest's Official Rules, which I have read and understand. I further represent as follows:

I am 14 or older as of October 29, 2009 in the state in which I reside; (If under the age of 18 at the start of the contest) I have the permission of my parent or legal guardian to enter the Contest and am entering into this agreement with their full approval and understanding; I understand that I may submit as many entries as I like to each of the four categories; I understand that Sponsor in its sole discretion may disqualify me if anything in the Submission or any information I submitted when registering for the Contest is not true. I further understand that this is not the only basis for disqualification, and that the Official Rules contain all such bases.

I represent and warrant that my Submission: (a) is my original work, (b) has not been previously published, (c) has not previous awards, (d) does not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity and the Submission complies in all respects with the Contest's Official Rules.

**SELECTION PROCESS.** I understand and agree the Submission and all materials and information included in it will be used for purposes of selecting prize winners in the Contest, and that the Submission may be shared among Sponsor and its public relations team, Contest judges, and others authorized by Sponsor to review the Submissions in the Contest and/or provide services during the Contest. In accordance with the Contest's Official Rules, the Contest judges will evaluate the Submissions based on the following criteria:

**Creativity/Originality: 25%      Appropriateness to theme: 50%      Clarity of Expression/Overall Quality: 25%**

I understand that the Prize winners in the Contest will be determined on the basis of a combination of the judges' scoring as described in the Official Rules. If I should receive any prize in the Contest, I understand that my parent/legal guardian and I will be required to sign an Affidavit of Eligibility, Liability Release and, unless I am a resident of Tennessee, a Publicity Release, all of which will be provided to me at a later date. I understand that the decisions of the Sponsor and the Contest Judges in all matters relating to the Contest shall be final, binding and not subject to challenge or appeal.

**USE OF THE SUBMISSION.** By signing the Contest Submission Agreement, I irrevocably and unconditionally assign and transfer to Sponsor all rights, title and interest in and to the Submission including, all intellectual property rights, and agree that Sponsor shall own the Submission (including without limitation the copyright and all other intellectual property and other rights embodied therein) and that Sponsor and its designees shall have the right (but not the obligation) to use the Submission for or in connection with the Contest (including posting on Sponsor website) and for all other commercial purposes in any and all media now known or ever developed in the future throughout the universe in perpetuity at no cost to Sponsor and without requiring compensation to me or further permission or notice from me for such use, except where prohibited by law. Sponsor and its designees shall have the right to post, exploit, publish, add to, subtract from, change, revise or otherwise edit the Submission. I release and will indemnify Sponsor from and against any claims arising out of such actions or the use of any rights granted herein. I understand that a complete description of Sponsor's rights in this regard is contained in the Contest's Official Rules. I waive all rights that I may have under any laws or statutes worldwide that concern "moral rights" in connection with the Submission, unless prohibited by law. I understand that Sponsor assumes no responsibility for any similarities between any Submission and any future advertising or promotional activities or other initiatives undertaken by Sponsor, except to the extent that a Submission may be used, in whole or in part, in such advertising, promotional activities or other initiatives in accordance with the terms herein and in the Contest's Official Rules.

**IMPORTANT:** I UNDERSTAND AND AGREE TO THE TERMS OF THE OFFICIAL RULES AVAILABLE AT [www.zanesville.ohiou.edu](http://www.zanesville.ohiou.edu). I agree that all information submitted as a part of the Contest is subject to the Sponsor's Privacy Policy. The invalidity or unenforceability of any part of this Agreement shall in no way affect the validity or enforceability of any of the other terms contained in this Agreement or in the Contest's Official Rules. In the event of an inconsistency between the terms of this Agreement and the Official Rules, the terms of the Official Rules shall govern.
